The Chair informed the Committee that several locations downtown had promised donations for the silent auction as well as several city orgnaizations including the Fire and Police Departments. Mrs. Gupril agreed to make up and print the bidding and information sheets for the event. The Chair also stated that she had 50 tickets printed at a cost of \$16. She and Ms Ward had been busy organizing the decorations for the event and a cost of no more than \$200 had been allocated for those decorations although the Chair felt that they would not require that amount. The estimated cost of the food that would be provided by Forty Five Market Street Bakery and Cafe would be around \$600.

Mike Pomp would be DJ for the evenings event at a cost of \$300. He would also provide lights and sound equipment. It was agreed that tickets would also be sold at the door.

The Committee felt that they had time to discuss the idea of a door prize trivia and picked out questions from those that had been prepared by Ms. Ward. The remaning questions would be placed at each table and answers to the door trivia could be found by visiting the tables around the room.

The group agreed to meet at 6.30 on Friday November 9<sup>th</sup> at the 1899 Ballroom to decorate the Hall ready for the event.
