Again, the Finance Committee met with City staff to discuss the attached three (3) Requests for Proposals received. City staff & School staff recommended a 3-year contract with our present auditor with no additional option years. At the end of the three years, staff would go back out for new proposals. Please note that although the City retains our present auditing firm, a new auditing manager will be assigned.

ORDINANCE NO. 21-15 AMENDING CHAPTER 19 ZONING ORDINANCE, SECTION 20, SIGN REGULATIONS.

Somersworth NH April 20, 2015

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the Ordinances of the City of Somersworth, as amended, be further amended as follows:

Amend Chapter 19 City of Somersworth Zoning Ordinance, Section 20 Sign Regulations by ADDING the following new provisions:

19.20.B.7 <u>Bus Shelter Sign:</u> Any sign affixed to an enclosed bus shelter below the roof line and is visible from any public right of way.

19.20.3.y <u>Bus Shelter Signs</u>: Provided that the total sign area of all signs affixed to the bus shelter shall cover no more than 50% of the total glass surface of the shelter.

This Ordinance shall be effective upon its passage.

Somersworth, NH May 4, 2015

WHEREAS, the fiscal years 2016-2021 Capital Improvement Plan contains a recommendation for the purchase and installation of an updated financial management system, and

WHEREAS, city staff solicited sealed bids from qualified providers and recommends contracting with Tyler Technologies, Inc. for an amount not to exceed \$250,000 (Two Hundred Fifty Thousand dollars) for the purchase and installation of an updated financial management system, and

WHEREAS, city staff also recommends approval of an additional \$25,000 (Twenty Five Thousand dollars) as contingency for unanticipated hardware and networking equipment that may be necessary as part of this project which may be purchased from other vendors, and

WHEREAS, the Finance Committee for the City of Somersworth has reviewed the recommendation and supports the recommendation,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the City Manager is authorized to contract with Tyler Technologies, Inc. of Yarmouth, Maine for the purchase and installation of a financial management system for an amount not to exceed \$\$250,000 (Two Hundred Fifty Thousand dollars) and is further authorized to expend an additional amount up to \$25,000 for any other related costs to complete this project, and

BE IT FURTHER RESOLVED THAT the City Manager is authorized to execute a five-year lease/purchase arrangement for an amount not to exceed \$275,000 (Two Hundred Seventy Five Thousand dollars) for the acquisition of the financial management system and unanticipated hardware and networking equipment in order to meet the needs and best interests of the City.

MEMORANDUM

Re: Financial Management Software

Please accept this memorandum as an update on the status of our request for proposal for a financial management system. We have met with each consultant that responded, and after review have concluded that Tyler Technologies MUNIS system is the best alternative. In addition to the demonstration of the capabilities of their system we also considered the following:

- They currently support a number of clients of similar or larger size (Rochester, Derry, Windham, Bedford).
- Tyler Technologies current provides software and support to the Somersworth School Department.
- We toured Rochester to get a feel for their system in action, and Rochester is close and could provide guidance especially through the conversion.
- They are currently going through an implementation in Goffstown. In speaking with staff in Goffstown they have been pleased overall with the conversion and implementation.

We have broken down the cost to license, implement, and convert our data to the MUNIS system. Implementation includes all necessary staff training. The cost breaks down as follows:

- Overall estimated cost to license, implement and convert is \$246,225.
- That cost would be split between the General, Water, and Sewer Fund on a percentage basis. I have calculated that split at 65% G/F, 18% Water, 18% Sewer.
- I recommend considering a 5 years lease/purchase to cover the cost of implementation. The estimated annual payment for a 5 year lease is \$55,982. (\$36,142 G/F, \$9,916 water, \$9,803 Sewer).

There is an annual maintenance and support fee of \$20,116. That would provide support, maintenance, updates, and quarterly user groups. By way of comparison, our current annual maintenance fee for the VADAR system is \$15,611.

Although there would be a slight increase in our annual support contract, we would be implementing modules such as purchasing (purchase orders and requisitions), HR management, budgeting, and a citizen self-service portal, all of which we currently do not provide.

Please let me know when you would like to discuss further.

Red Cross Partners with Liberty Mutual To Install Smoke Alarms, Teach People Fire Safety in Somersworth

Nationwide campaign aims to reduce the number of home fire deaths, injuries

Concord NH, April 30, 2015 – New Hampshire American Red Cross Volunteers, along with employees from Liberty Mutual, will be visiting Colonial Village on Blackwater Road, Sherwood Glen Mobile Home Park and the areas of Washington Street, Indigo Hill Road, Green Street and Main Street in Somersworth as part of its Home Fire Preparedness Campaign to teach people how to be prepared for home fires and install smoke alarms where needed.

Seven times a day someone in this country dies in a home fire. Countless others suffer injuries. To combat these tragic statistics, the Red Cross has launched a nationwide campaign to reduce the number of deaths and injuries due to home fires by 25 percent over the next five years.

The Home Fire Preparedness Campaign is happening all over the country and involves Red Cross workers joining with local fire departments and community groups to visit neighborhoods at high risk for fires. Those visits include educating people about fire safety through door-to-door visits and installation of smoke alarms in some of these neighborhoods.

Liberty Mutual employees are participating in this endeavor as part of their annual Serve with Liberty volunteer days to make a difference in local communities throughout the country and around the world. "Installing smoke alarms cuts the risk of someone dying from a home fire in half, so we're joining with Liberty Mutual this week in the Somersworth community to install smoke alarms," said Maria Devlin, Regional Chief Executive Officer, "We also will be teaching people how to be safe from home fire."

Simple Steps to Save Lives

The Red Cross is asking everyone to take two simple steps that can save lives: check their existing smoke alarms and practice fire drills at home,

There are several things families and individuals can do to increase their chances of surviving a fire:

• If someone doesn't have smoke alarms, install them. At a minimum, put one on every level of the home, inside bedrooms and outside sleeping areas. Local building codes vary and there may be additional requirements where someone lives.

- If someone does have alarms, test them today. If they don't work, replace them.
- Make sure that everyone in the family knows how to get out of every room and how to get out of the home in less than two minutes.
- Practice that plan. What's the household's escape time?

Dear Scott:

Earlier this year, favorable market conditions allowed the New Hampshire Municipal Bond Bank to refinance a portion of its outstanding debt. A portion of this refinanced debt was originally issued to make one or more loans to your community. This refinancing resulted in a net debt service savings to the Bond Bank. In the past, the Bond Bank has returned savings to the communities by issuing a check to the community for the total amount of savings. We were not able to structure the 2015 Series A refunding to provide up front savings. The Bond Bank has determined to return savings realized through this refinancing to each borrower, whose loan was funded through the Bond Bank's refinanced debt, by revising the original debt service schedule. The savings allocable to each borrower is based upon the amount of the loan that was included in the particular maturities of bonds refinanced by the Bond Bank.

Please replace your original debt service schedule with the revised schedule enclosed with this letter. The revised debt service schedule reflects the savings allocated to your community.



SUBJECT: Meeting With Pike Industries

Public Works and Engineering staff met with Pike Industries this afternoon to review Pike's proposed schedule for completing the wearing course pavement on Blackwater Road and Whitehouse Road as well as the striping on High Street.

Pike's proposed schedule to complete the paving project work is as follows (weather permitting).

<u>First two weeks of May</u> – Blackwater Rd & Whitehouse Rd prep and pave; striping to follow depending on temperatures. Corrective work discussed with Pike included:

- > Fortify subgrade and improve pavement transition at the intersections of Blackwater Rd with Old Rochester Rd and Route 108;
- > Prep and seal cold joints before placing wearing course pavement.

<u>Mid-May to mid-June</u> — corrective work on High Street and striping. Corrective work discussed with Pike includes:

- > Repair damaged signal loop at Kelwyn Drive;
- > Replace failed striping at High St;
- > Improve pavement transition from High Street to Stackpole Rd at intersection;
- > Improve pavement transition on north end of project;
- > Improve pavement transition at Wal-Mart driveway:
- > Take grade shots along curb line between Market Basket driveway and Tri-City Road;
- Clean out excess asphalt from all SMH, DMH, WG covers.
