- 4. Police Department Intern. I am pleased to inform you that we have another college intern, Lauren Baylor from Great Bay Community College. Lauren will be working on the PD website updating their content as well as researching the benefits for the department's possible use of social media.
- 5. Serve with Liberty. Attached is a memorandum that provides details on the Serve with Liberty Program. Again, this year the City in partnership with Liberty Mutual will have the use of 50 volunteers to work on several City Projects:
  - Mast Point Dam
  - Noble Pines Ball Park
  - Willand Pond Trail.

Re: Transportation Enhancement (TE) grant update

I am writing this memorandum to provide you with an update regarding the TE grant. We submitted the attached Preliminary Design Report last week for NHDOT review. As you will note from the enclosed preliminary estimate, we are within the budget of the grant award. Moving forward, we anticipate the following schedule:

- Mid-April Receive comments from NHDOT on Preliminary Design Report and Notice to Proceed to Final Design
- Mid-June Submit Final Design to NHDOT for their review
- Mid-July Receive comments from NHDOT and receive approval of Final Design
- Mid/Late July Bid the project
- Early to Mid-August Award the contract and start construction

Please note that the above schedule is a best case scenario and it depends on several factors out of our control such as NHDOT review time and the NEPA process. I have spoken with C.R. Willeke at NHDOT and Greg Bakos at VHB and they both agree that the above schedule is reasonable at this point. I will continue to move ahead as expeditiously as possible to be in a position to complete the TE work concurrently with the downtown improvement project.

New Hampshire Emergency Notification System (NH-ENS)

As per your authorization, I contacted the state relative to their offer of a <u>telephone</u> <u>emergency alert warning system</u> for citizens in each city or town in New Hampshire during a public safety emergency. RSA 21-P:38 confers upon the state Division of Emergency Services and Communications (DESC) the responsibility to ascertain means for rapid and efficient communications during natural and man-made disasters.

#### The DESC established NH-ENS as an:

- automated computer-based system
- multi-line telephone messaging system and emergency alert warning system
- can be voice, text or e-mail based
- uses GIS and advanced "911" mapping for customer listings

The system is activated when an authorized official (Town or City Manager: Police Chief; Fire Chief; Emergency Manager; certain elected officials) from an approved community contacts DESC with an emergency message and DESC then transmits such message to residents in that community. Emergencies are considered to be immediate or imminent public safety threats such as:

• tornado, hurricane, severe wind, hazardous materials incidents, evacuations, escaped prisoners, armed shooters, etc.

Non-emergency messages will NOT be broadcast, such as:

• school closings, No Parking announcements, notices of public meetings, etc.

Currently Somersworth uses Nixel, Channel 22, the city website and the City Manager's e-mail "Blast" network to get out announcements. This state system is one more avenue for the City to utilize to get out emergency messages to citizens and there is no cost to the City.

The state can have the NH-ENS system operational for Somersworth immediately after they receive all of our designated officials' "User Account" forms.

This memorandum is in response to your request for an update on the Serve with Liberty program. As you know, Liberty Mutual has contacted us about this annual program that provides volunteers to perform a variety of community service tasks. As in prior years, we are taking advantage of this great program and will be completing the following projects during the week of May 5th:

- 25 people will be utilized to clear a trail network at the Mast Point Dam area (Team leader Dave Sharples);
- 15 people will be utilized to scrape and paint the concession stand, dug outs, and stairway at the Noble Pines. The features will be painted Royal Blue and Trimmed out in White (Team leader Nick Campion).
- 10 people will be utilized to complete last year's project of rebuilding the remaining boardwalk sections along the trail around Willand Pond. These folks will also provide assistance to repair the dug out seats at Noble Pines (Team leader Tim Metivier).

Since we will be utilizing 50 volunteers, Liberty Mutual will also provide the City a check for \$1,000 to help offset any costs associated with the projects such as paint, wood, etc. As noted above, City staff will serve as team leaders to guide the projects to completion.

Dear Mr. Streeter:

Please accept this as the City's Annual request for funding related to activities performed at the Somersworth Landfill Superfund Site and services performed on behalf of the Somersworth Landfill Superfund Site Group. It is necessary to provide funding to the Landfill Site Group escrow account to allow payment of invoices for engineering services for this project and continued monitoring and reporting as required by the Consent Decree entered into with US-EPA as well as NH DES reporting requirements. At this time, I have estimated a budget of \$160,801.00 for services for the up-coming Fiscal Year ending 6/30/2015.

Therefore based on the City of Somersworth/General Electric Co. Agreement for the Remediation of the Somersworth Landfill, the GE share is 49.5% or a total of \$79,596. The City of Somersworth has budgeted its share at \$81,205.

#### Greetings,

I recently met with a very lucky business that doesn't have to invest an exorbitant amount of time and money on marketing. Their luck came from spending 26 years in business creating goodwill through consistent quality in both product and service. After many years in business they may not have to worry as much about newspaper or online advertising. They may not feel the need to network after work or continuously post compelling stories and

thoughts on their LinkedIn and Facebook pages.

For those of us that are not yet lucky enough to have put in 20 + years of determined efforts we still need to consistently market our business. If we don't promote what we offer, we don't grow. Marketing opportunities are plentiful ranging from the traditional to the extreme.

Publicity stunts can draw a lot of attention to your business ("Dumb Starbucks" in LA and Warren Buffett's "\$1 Billion March Madness" come to mind) but don't assume they will work for you. The coffee shop, Dumb Starbucks, was quickly shut down by the health department and I haven't seen a headline since. Very few can afford Warren Buffett's gamble and quite frankly I just don't think he needs anyone else to know who he is. Perhaps there is something a little less extreme but still unique that a business can do to draw some attention. If you decide to go down this route there are a few things to consider:

- 1. If this is successful and grows my business, am I ready to handle that growth?
- 2. Will it show my business in a positive light?
- 3. If it works can I repeat it or will it lose its appeal?
- 4. What will it really cost me? Have I truly thought it out?

Think about shopping sprees that allow consumers to fill their carts with anything they can grab in a defined amount of time. Offer that at a BJ's forgetting that they sell electronics in addition to meat and toilet paper and

you just blew your marketing budget for the next five years. Laptops add up much quicker than even the finest cut of steak.

I do believe that some "publicity stunt" type marketing can be a fun and hopefully successful way to draw some attention to your business if done well and done sparingly.

Overnight successes often become one hit wonders so the truly lucky folks will be in it for the long haul. As an old friend of mine once said, "The harder I work the luckier I get."



### Somersworth Fire Department Receives FEMA Grant

The City has received a \$99,000 FEMA Grant to hire more call firefighters. The Federal Emergency Management Agency's SAFER grant will pay for virtually all costs associated with recruiting, equipping and training new call firefighters over the next two years. It also provides money for computers, an exterior sign at the Maple Street fire station, fire education courses and EMT training for several new hires.

Chief Hoyle said the Grant will rebuild the City's pool of call firefighters, which once numbered around 20 but fell to less than 5. Call firefighters respond to fires and other emergencies within Somersworth and provide station coverage when the City's full-time firefighters are called to other communities.

The City has nine active call firefighters now, and is currently looking to hire more, Hoyle said. Over the next two years, he hopes to hire 11 new call firefighters. Somersworth has 16 full-time firefighters. Call firefighter jobs are a good way for anyone interested in a firefighting career to get a taste for the position, he said. It's also a good opportunity for people with jobs to give back to the community. Candidates interested in the open positions can apply at the Maple Street Station or City Hall. #### Bagged Leaves & Brush Pick-up

Brush will be picked up the third week in April and the third week in May. You must call 692-4266 by Friday, April 18th and/or Friday, May 16th to be added to the pickup list. Please have your brush curbside no later than 7 a.m. on Monday, April 21st and/or Monday May 19th for pickup. Brush can be up to five (5) inches in diameter and ten (10) feet long. PLEASE NOTE: Brush pickup is limited to 20 minutes per stop. Any remaining brush and cleanup of debris is the responsibility of the property owner. Bagged leaves will be picked up the



fourth week in April and the fourth week in May. You do not have to call ahead for bagged leaves pickup. Please have leaves curbside no later than 7 a.m. on your trash pickup day the week of April 28th and/or May 27th. Leaves and grass clippings must be in brown paper leaf bags, sold at many local stores. Malley Farm Facility will be opening in April for disposal of brush and leaves, weather conditions permitting. Call the Public Works Department at 692-4266 for hours of operation.

**Items that WILL be accepted:** Oil or enamel based paint, stains & finishes; Paint thinners & turpentine; Weed killers & fertilizers; Insect & rodent sprays; Pool chemicals & antifreeze.

Items that WILL NOT be accepted: Zinc & alkaline batteries; Propane tanks; Car batteries; Latex paint; Computers; Motor oil & tires.

#### **Exemptions & Credits**

Applications for Elderly Exemptions and Veteran's Credits are due no later than April 15<sup>th</sup>, 2014. The guidelines for the Elderly Exemption are as follows:

- 1. The taxpayer must be 65 or over.
- 2. The taxpayer must be a New Hampshire resident for at least three (3) years as of April 1st and own the real estate individually or jointly, or, if the real estate is owned by such person's spouse, they must have been married for at least five (5) years.
- 3. The taxpayer must have gross income of not more than Thirty Thousand (\$30,000) Dollars, Single or, if married a combined gross income of less than Forty-Five Thousand (\$45,000) Dollars.
- 4. The taxpayer must not own assets in excess of Eighty Thousand (\$80,000) Dollars, excluding the value of the person's residence and up to 2 acres of land.



2 eggs
3/4 cup each of white sugar and brown sugar
1/2 cup of miracle whip
1 tsp of vanilla extract
1 tsp of baking soda
2 cups of flour
1 package (14 oz) of kraft caramels
1 cup of bakers semi sweet chocolate
1/2 cup too 1 cup of chopped pecans
1/4 cup of milk

Beat eggs, sugars, miracle whip and vanilla Ext at medium speed, add flour and soda. Set aside 1 cup of the batter. Spread remaining batter into lightly greased 13 x 9" pan. Bake at 350 degrees for 12-15 minutes or until it browns. Melt caramels with milk in heavy saucepan over low heat stirring frequently until smooth. Top crust with caramel mixture sprinkle with chocolate chips and pecans. Spoon reserved batter by teaspoon over chips and pecans, Continue baking 12-15 minutes or until browned.
