Old Business (Under Section 14 of Agenda)

#### Resolutions

- A. Resolution No. 23-20: Proclaiming Somersworth a Welcoming City. The Government Operations Committee met on January 22<sup>nd</sup> and voted to amend this Resolution. Attached is a redline copy of their proposed amendments. I have also attached a copy of the email from former Councilor Ed LeVasseur that provided a link to the organization's website.
- B. Resolution No. 27-20: Displaying a Permanent Photo of Former Mayor James McLin in the City Council Chambers. Again, this Resolution follows the same format as the Resolution Council passed for former Mayor Fred Brown's Photo in Council Chambers.

New Business (Under Section 15 of Agenda)

#### Resolutions

A. Resolution No. 28-20: Vote to Support House Bill 1111, an Act Relative to the Removal and Replacement of Telephone and Electric Poles. The Public Works & Environment Committee met on January 15<sup>th</sup> & discussed House Bill 1111. This HB will establish rules and regulations that require a schedule for the removal and replacement of telephone and electric poles. Attached is a copy of the Bill that was brought to City Staff's attention by NH State Rep. Gerri Cannon. There is also is a copy of several double pole locations in the City prepared by Director Mike Bobinsky; please note there are others not yet listed. The Committee recommends the full Council vote to support this Bill. I suggest Council consider waiving Council Rules to act on this Resolution this evening so that the Resolution can be presented to the House Municipal & County Government Committee at their hearing on Tuesday, February 4<sup>th</sup> in Concord.

**B.** Resolution No. 29-20: Vote to Authorize a Bond to Replace the Elevator at the Somersworth Middle School. The Joint Commission of Council & School Board voted at their January 16<sup>th</sup> meeting to support this action as did the Council's Finance Committee on January 29<sup>th</sup>. Attached is a copy of Finance Director Scott Smith's financial summary regarding a potential bond issuance and the project estimate provided by Superintendent Robert Gadomski. The Finance Committee is recommending a 15-year Bond, and also accepted staff's recommendation to round the estimate up to \$650,000. Once final costs are determined, the City will only Bond the actual amount needed to complete the project.







#### **ANALYSIS**

This bill establishes a required schedule for the completion of the removal and replacement of telephone and electric poles by a distribution, electric, or telephone company.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 New Section; Telephone and Electric Poles; Removal and Replacement. RSA 231:181 is repealed and reenacted to read as follows:

231:181 Schedule for Removal and Replacement. A distribution company, electric company, or telephone company engaging in the removal of an existing pole and the installation of a new pole in place thereof shall complete the transfer of wires, all repairs, and the removal of the existing pole from the site within 90 days from the date of installation of the new pole; provided, however, that for any approved commercial or industrial construction project, the completion of which is expected to take longer than one year, said company shall be required to remove such pole within 6 months from the date of installation of the new pole. The owner of such pole shall notify all other users of the starting date of such removal and installation work at least 48 hours prior to the commencement of such work, and said owner shall require all other users to remove their wiring and other attachments from the poles in a timely manner.

2 Effective Date. This act shall take effect 60 days after its passage.

Geri has ask I provide her with a list of double poles in the City for background with her bill. In addition, she asked if I can offer consequences/impacts of the double poles

Some of the consequences about the double poles are the following:

- -Safety-; some of the double poles are wrapped with metal bands around the new pole to hold them up. I have needed to respond to citizen complaints/concerns that the older poles may break off or fall over and report said condition to Consolidated or Eversource to inspect.
- -Sight Distance impacts: Pole placement at or near intersections can contribute to line of sight issues for motorists. Double pole installation when at intersections adds to this sight distance problem for motorists and pedestrians.
- -Access issues when near or at sidewalks- Placement of poles is critical to a walkable neighborhood and when double poles exist, makes it difficult if not impossible to stay on sidewalk forcing pedestrians to walk in the street; less safe. In addition, if those double poles are on a sidewalk snow clearing route, our sidewalk tractor is unable to clear that section of sidewalk contributing to even more restrictions and unsafe conditions for pedestrians.
- -Aesthetics. The double poles degrade the appearance of a street/neighborhood. Often those left over poles are in a deteriorated condition and brings down the appearance of the properties it abuts or neighborhood streets.



# VOTE TO AUTHORIZE A BOND TO REPLACE THE ELEVATOR AT THE SOMERSWORTH MIDDLE SCHOOL

#### February 3, 2020

WHEREAS, the elevator at the Somersworth Middle School is essential to providing access for every student to all sections of the Middle School; and

WHEREAS, School Officials recommend replacing the elevator due to its age, concern of its reliability, and lack of access to replacement parts that may be required to repair the elevator should it stop working, and

WHEREAS, the estimated cost to replace the elevator is \$650,000 (Six Hundred Fifty Thousand dollars), and

WHEREAS, the project costs include architecture, engineering, construction, and any other ancillary costs associated with the project;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT an amount not to exceed \$650,000 (Six Hundred Fifty Thousand dollars) is appropriated to replace the elevator at the Somersworth Middle School; and

#### BE IT FURTHER RESOLVED THAT:

- (a) the City Manager is authorized to borrow up to \$650,000 (Six Hundred Fifty Thousand dollars) under the Municipal Finance Act and issue bonds and notes payable within 15 years from their dates, and
- (b) the City Manager is authorized to issue temporary notes in anticipation of the issue of these bonds or notes, and
- (c) the City Manager is authorized to apply for, obtain and accept federal, state or other aid, if any, which may be available for said project, and
- (d) the estimated useful life of this project is expected to exceed 15 years.

Re: School Elevator - Potential Bond Issue

In response to your request on a potential bond issue for the School Department to replace an elevator, please accept the following:

- The School does have debt that expired this year, issued in 1999, that will reduce their debt service payments by approximately \$15,400 in the FY2021 budget.
- Assuming a \$600,000 project, first year Principal and Interest cost for a 10 year bond issue is estimated to be \$72,000.
- There is a possibility to combine this issue with a potential City issue for the Cemetery Road project in the fall, this would save money on issuing costs.
- Any approved bond resolution could authorize the use of Bond Anticipation Notes (BAN) which would provide the funding to complete the project this summer and delay the actual bonding to combine it with other issues.
- The School would need to budget for the interest payment that would be due for a BAN, which would be approximately \$8,000 \$9,000.
- There would also be legal fees associated with any Bond Issue and BAN. The School could include those costs with the cost of the project, or budget them separately. Typically those costs are approximately \$5,000-\$7,500.

Re: Somersworth-Dover Water Interconnection Testing

The following is a brief update on the Somersworth-Dover water interconnection project.

The project is approaching substantial completion, and key milestones have been reached including pipe installation, pump house construction, and installation of the booster pump and water meters. Department of Public Works staff met with City of Dover staff, the City of Dover's contractor (Scherbon Consolidated, Inc.), and the City of Dover's design engineer (Underwood Engineers) on-site at the interconnection on Wednesday, January 29, 2020 to conduct a test simulating a water emergency for each city. The test was conducted from approximately 8 am through 11:00 am. The test involved the following steps:

- Pre-test procedures were set including maintaining normal water storage tank levels in both systems and the hydrant outside of the Willand Pond pump house building was flushed.
- A one-hour test from approximately 8:30 am to 9:30 am was conducted, sending water from Somersworth to Dover at approximately 850 gallons per minute, (gpm) Flow rates were within the theoretical estimated range for the given storage tank levels in both systems.
- Somersworth's system water pressure and tank levels were monitored and recorded on a systematic basis throughout the test; no abnormalities or concerns were observed during the test.
- Valves were gradually closed starting at 9:30 am and system pressures were allowed to stabilize following the first test.
- Valving and flows were reversed and water was pumped from the Dover system back to Somersworth's system at approximately 680 gallons per minute (gpm), (the maximum design flow) for approximately 75 minutes. The test started at approximately 9:45 am and concluded at 11:00 am.
- Somersworth's system water pressure and tank levels were monitored and recorded on a systematic basis throughout the test; no abnormalities or concerns were observed during the test.
- The interconnect was closed and each system returned to typical operating conditions.

- -The development of a set of Standard Operating Procedures (SOP's) for accessing the water system interconnect by both water systems is underway and will be included as part of the final project completion work.
- After project completion/acceptance, I recommend that the water interconnect system be exercised annually by personnel from Dover and Somersworth water systems and incorporated in with the SOP's.

Underwood Engineers is collecting data gathered on the tests to confirm that plant outputs, tank levels, etc. match the in-field flow and water level calculations. Department staff will be notified with the results of the office calculations, and if there are any discrepancies from the expected results. The field tests conducted indicated no problems and indicate the interconnect is ready for commissioning upon final project completion – expected to be complete in late spring 2020. Overall we were pleased with these initial results.
