A. Mark Harrington is seeking a Conditional Use Permit to construct a stormwatertreatment area and pavement within the wetland buffer for a property located at Route 108/Enterprise Drive in the Commercial Industrial (CI) District, Assessor's Map 48 Lots 24D & 24H, CUP#05-2020

R. Stowell presents for the applicant; applicant, applicant's architect and landscape designer is present as well. Application involves merger of two separate lots and construction of a warehouse for a moving storage business of 23260sft. This will include a small (600sft) office. Parking will be provided for employees and customers on site. Full plan is available at meeting; CUP-1 was provided prior to meeting. All stormwater on site is directed to a retention pond through catch basins and sheet flow. Landscape architecture here includes entirely native, food-producing species, at all levels (canopy tree to shrub/grass). Plantings will be emplaced in clusters in order to replace vegetation disturbed by the construction process. The commission expressed high praise for the design.
