A. Michael Davis is seeking a conditional use permit for after the fact excavation and alterations within the Riparian and Wetland Buffer on a property located at <u>25 Otis Road</u>, in the Residential/Single Family (R1) District, Assessor's Map 31, Lot 49, CUP#03-2023.

The applicant has requested a continuance to November, as he is coordinating with his surveyor to provide the plans as requested in the September meeting. No other developments have occurred; the next court hearing regarding this item is scheduled in March.

J. Degler moves to table the request until the October meeting; J. Rhodes seconds. Motion carries 6-0-0.

Note that there is apparent soil movement from a site on Copperhead Road; this will be referred Code Enforcement.

Bittersweet growth has been noted throughout the city; recommendation to cut near soil line and remove growth in a trash bag.

#### iii. Exploration of formal conservation of Malley Farm city parcel

K. Dodds is not here to provide an update tonight; a project sheet is out, with the intent being to formally conserve the land prior to initiation of the trail project. Council approval is required to conserve the land; this should be discussed shortly.

## iv. City tree GPS inventory project

D. Bryar and K. Dodds met to discuss; there's a need for an ESRI license to use the app. Amber Hall, City Engineer, has confirmed that the City has one to provide access. Elizabeth Durfee, the contractor who assisted with Dover's inventory, was also contacted. She coordinated volunteer labor for the project; 16 volunteer surveyors were involved, with a total of 72.5 hours of time logged. She could provide training for us as well, presumably for a fee. Dover's survey covered only the central business district. 327 trees were included, at a cost of approximately \$12,000. Dover did utilize grant support for the project. We'd want to prioritize our areas of inventory, with actual inventory happening in April or May. We'll need to determine cost centers. Elizabeth Durfee is willing to speak to the commission; D. Bryar will determine her availability.
