### **E911 Committee Meeting Minutes** **November 20, 2018**

**The E911 Committee Meeting was called to order at 0900 hours by Chief Kretschmar in the conference room of the Somersworth Police Department.**

- 1) The naming of streets within the River Valley Development Corporation project on Green Street just south of Indigo Hill Road was discussed. Denise Madden had originally provided three names, Greenridge Road as the main road coming off of Green Street, then Stillwater Lane branching to the right off of Greenridge, and Meadow Way branching to the left off of Greenridge. The Committee felt that Greenridge was too close to Green Street and Greenfield Drive and was not comfortable with that name. Chief Kretschmar suggested naming the main road off of Green Street as Meadow Way or Lane, and the interior road as one name, Stillwater Circle. After discussion, and consent by Denise Madden, Paul Robidas made the motion to name the main road coming off of Green Street as Meadow Way, and the interior road intersecting with Meadow Way as Stillwater Circle. Motion seconded by Chief Hoyle, motion passed 5-0, with a resolution to be presented at the December 3<sup>rd</sup> City Council meeting. Numbering will be completed by the City Engineer.**
- 2) The resident/owner of 172 Green Street has requested address renumbering as the structure is now a duplex with top and bottom apartments. After discussion a motion was made by Paul Robidas to**

**renumber the structure as 172A and 172B Green Street, with 172A being the bottom floor. Motion Seconded by Director Bobinskiy, passed 5-0.**

- 3) There was a brief discussion on renumbering of 15 Wolcott Street as that residence has 7 Wolcott to it's south, and 6 Wolcott Street directly across. Director Bobinsky and the City Engineer, Gary Lemay, will research as to the impact that renumbering 15 Wolcott may have on future projects on that street.**
- 4) There was a brief discussion on the status of Colonial Village street name changes. Director Bobinsky has spoken to Peter Pope, the park owner, who has stated that street signs have been ordered but not received yet. Director Bobinsky will follow up with Mr. Pope to get the signs erected.**
- 5) Discussion was had as to the address of Portland Glass on Route 108 near the Dover/Somersworth City boundary. While the property is in Somersworth, it has a Dover mailing address. We have encountered this before, the mailing address is due to contractual and union issues between the Dover and Somersworth Postal Services. While Somersworth emergency services respond to calls for services there, it will remain with a Dover mailing address.**

**At 0953 am, a motion to adjourn was made by Councilor Pepin, seconded by Chief Hoyle. Motion passed 5-0 and the meeting was adjourned.**
