- Repairs and installs fire hydrants, water mains and services.
- Tests and certifies backflow devices in accordance with State requirements.
- Maintains records and completes reports as required.
- Participates in the preparation of the water distribution system operation and maintenance budget, monitors and documents expenditures assuring compliance with approved budget and staffing levels.
- Collaborates with the City Staff and Site Review Technical Committee on new construction projects.
- Conducts tests to locate water leaks; flushes hydrants to maintain water quality.
- Checks/lubricates motors, pumps, bearings, universals and valve stems.
- Inspects private contractors work to ensure compliance with city requirements.
- Responds to inquiries, complaints, problems or emergencies affecting the availability or quality of water supply services from the public.
- Supervises and evaluates the performance of assigned staff; plans, coordinates and arranges for appropriate training; inspects work performed.
