The meeting was called to order by His Honor, the Mayor, Dana Hilliard, and upon roll call the following Council members were present: Pepin, Soldati, Dumont, McCallion, Messier, Witham, Sprague, Cameron, and Paradis.

MINUTES OF THE PREVIOUS MEETING.

MINUTES of PUBLIC HEARING Fiscal Year 2017/2018 budget for the City of Somersworth.

Councilor Messier, seconded by Councilor Paradis, made a motion to accept the minutes. The motion passed unanimously

MINUTES of the CITY COUNCIL MEETING held on November 6, 2017

Councilor Messier, seconded by Councilor Cameron, made a motion to accept the minutes. The motion passed unanimously

COMMENTS BY VISITORS

Richard Gagnon, spoke about an issue that transpired regarding the raising of the Atheist flag. He wanted to thank the City for their support.

COMMENTS BY COUNCILORS

Councilor Witham would like to add to the agenda item other C, regarding the proposed improvements to WWTF as presented by Wright Pierce Engineers. There are no objections from the Council.

Councilor Soldati debated on whether to make a comment. Since our last Council meeting something historic has happened in this Country, the 'Me Too' movement has come to light. She bravely shared that she as a child was molested, sexually assaulted as a middle schooler and by an orthodontist and inappropriate sexual innuendoes by a Priest at St. Thomas Aquinas. She feels that this is wonderful that men are listening and are hearing us as Women; she believes that the country has come a long way. Women know the difference between flirting and being treated in a sexually inappropriate way. Tells City employees, School employees and women out there that have been silent she would encourage them to come forward. She also would also like to thank the citizens of Somersworth for supporting her.

Councilor Paradis wished good luck to Edward Levasseur and Kenneth Vincent, two new Councilors. Paradis shared that she is not returning due to her Dad being sick and is taking in her parents due to illness. She started as a care taker within this City and will continue to do so. She has been proud to serve this community. She echoed what

Councilor Soldati said as well regarding the ‘Me Too’ movement. It is no secret she has talked to the newspapers, NH Senate, NH House, Mayor and anyone that would listen. She thought it was funny when a former candidate in the previous race said that she was deceitful. She responded with “I am anything but deceitful.” She says what she means and means what she says, whether you hate me, think that I am a radical feminist, vegetarian, Atheist, and ‘Me Too’ as well throughout her lifetime. We have had the Community programs come forward to get funds from the City Council for different services they provide, such as sexual assault support services now known as Haven. When they came to the Council the last couple of times talking about the numbers of 1 in every 3 women and 1 in every 6 men were abused. When she looked around the room knowing everyone there and seeing that those numbers were accurate, except the numbers for women were more prevalent. She would also encourage anyone that has been in a situation to please come forward and tell someone and keep telling someone until the abuse or harassment stops. She thanked everyone and said she looks forward to serving again at some other point in her life.

Mayor Hilliard invited Councilor Paradis and Councilor Soldati to the front of the room. He thanked them on behalf of the City of Somersworth for their dedicated service and love for the Community. The Mayor presented each with a gift and well wishes for their future.

COMMUNICATIONS

PRESENTATION OF PETITIONS AND DISPOSAL THEREOF BY REFERENCE OR OTHERWISE

A presentation by Steve McKenzie, Chairman of Mayor’s Drug Abuse Task force and Rev. Mark Rideout, from Somersworth Prevention Coalition, would like to take a tag team approach to the opioid epidemic. They would like to merge the Mayor’s Drug Abuse Task Force and the Prevention Coalition. Each spoke about the steps from treatment and recovery to eventually prevention; they do believe that it takes a Community to do the work. Chairman McKenzie expressed that both organizations help to raise awareness within the Community.

With no objection from Council agenda item Other B has been moved out of order to speak to Chinburg regarding Resolution No. 25-17 Purchase & Sales Agreement with Chinburg Properties for the Re-use of the Former Hilltop Elementary School Property.

Manager Belmore stated that he asked the Mayor to place this on the agenda to allow for Eric Chinburg to speak to Council and answer questions if the Council chooses to suspend rules. Eric Chinburg has requested to move forward with the deeding of the property to Chinburg Properties, due to some changes or potential changes happening in

regards to federal legislation regarding historic tax credits. Manger Belmore would also like to provide some additional information to be completely transparent that when the Council passed this Resolution that it was planned to have 30 market rate apartments. Chinburg may still financially be able to offer those 30 market rate apartments and civic space. Chinburg did convey that he may be looking now at more of a mixture development of some apartments, artist lofts, artist studios and some business type offices. Or he may have to morph the project into a more business type use to make it more financially feasible. A 79E application has already been approved for Chinburg properties to move forward in regards to tax relief at a local level. At this point he is not asking for any zoning relief and he is prepared to follow all current ordinances and guidelines.

Councilor Witham thanked Manager Belmore for pointing out that Chinburg will stay within the parameters of the Historic Overlay District.

Councilor Sprague questioned deeding the property over to Chinburg early because of the snafu in Washington, without site plans. If they can't get zoning for individual apartments they may need to go with small business use, if that is not passed then what happens to the property, does it sit dormant again. This is the first time he has heard about a business aspect brought up in the planning for the former Hilltop School, he is not one that would be inclined to support that at all.

Manager Belmore responds that if zoning is not approved that Chinburg could sell it back to the City for same dollar amount.

Councilor Sprague asked if developer would pay legal fees as well, if the site plans didn't pass. He feels that parking spots for small business offices will take over, the once mentioned green space.

Councilor Messier commented he would like to see something done to the building. Potentially, a business may only be renting a spot for small office space. Whether it is a person renting an apartment or a lawyer renting an office space what is the difference. The plan is not to rent it out to a large business, just wants to rent to small business office spaces.

Councilor McCallion, seconded by Councilor Dumont made a motion to suspend rules to allow for Chinburg to take questions from the Council. Motion passes 9-0

Councilor McCallion stated that he has been in Committee meetings with Mr. Chinburg and he has answered every question and felt that this was a perfect time to ask Mr. Chinburg questions.

Eric Chinburg stepped up to the podium. He stated that he was not expecting this to happen, that there is a grandfather clause that states if the entity has owned the property in 2017 than they would qualify for the tax credit relief. His request is to accelerate the closing before approvals; he reiterates that if it is not owned by the end of the year then this project will not work. He also requests to modify the purchase and sales agreement to

say we will do whatever the zone allows, if the sale is made. He compared this project to a relatively new project done in Dover, NH, where it is filled with many different types of small businesses. It has been successful and popular.

Councilor Witham stated that we have fairly robust zoning regulations that this body adopts. We have the mechanics to afford us the protections for the sensitive neighborhood. He gets that it is a sensitive neighborhood but so are the abutters to Wal-Mart area and the Route 108 area. He has one fear that the building will sit vacant.

Councilor Dumont is open to residential housing or pop up business offices. With understanding to the current environment he feels that we continue with the support of moving the sale date up. He would support this action.

Councilor Paradis agrees with Councilor Dumont. She is not expecting a cigarette rolling company to come in and occupy the building.

Councilor Sprague asked if a yoga studio would be allowed, not sure if it is allowed in the zoning but that would allow for 8-10 people to attend a class at one time that leads to parking being an issue. What about putting Chinburg on the deed with the City, then after a plan is proposed and it passes we can do a quick claim deed. Chinburg answered that he is okay with deeding the property back at no cost to the City if the zoning doesn't pass.

Councilor Soldati stated that Chinburg has a long history in this City. She is going to trust him and supports him to move forward.

Councilor Pepin asked a question to Chinburg. In your experience under previous buildings have you seen an increase in parking spaces over business vs residential? Do you have figures? Chinburg responds that they are the same. Councilor Pepin thinks something needs to happen with the building as soon as possible.

Councilor Cameron feels building will sit and sit if we don't do anything. She is supporting the action.

Councilor Witham made a motion to allow the City Manager to modify the terms to the purchase and sales agreement as originally agreed to by the Council to Chinburg Properties with the provision of a buy back clause that if the developer cannot proceed with the project the developer will sell the property back to the City at no cost to the City, seconded by Councilor Soldati.

Councilor Sprague stated he will not support this, that this is not the original agreement. There has been no public hearing and people who live up on the hill have not had a chance to allow their voices to be heard.

Councilor Witham stated that he is struggling to find a time when a public hearing had anybody there to speak. At times he wishes he had a cricket sound on his phone because that is what some of the public hearings are like. He felt there have been times for the public to speak about zoning.

Councilor Messier stated the public will have a chance to have their say. He would like something to get done. Let's allow a process to move forward.

Councilor Dumont supports the motion. He hears a lot regarding parking issues in Somersworth; he has never heard a community more than Somersworth talk about a parking problem. People in Portsmouth will hunt for a parking spot, walk and pay extra to find one. The new Great Falls reception place and parking their parking was brought up as an example.

Councilor Sprague stated that there is parking on one side of street currently. He suggested that City Staff and Council drive up on those hills and see why parking is an issue. Fire trucks are not able to get through if people are parked on both sides of the streets. The streets on the hill are already narrow; there are issues with people trying to get into their driveway. Fire trucks are not able to get through if people are parked on both sides of the streets. If this facility is made into businesses where are they going to park, that is the point he is trying to make especially when snow is added to the problem.

Motion passed 8-1 by roll call vote, Councilor Sprague opposing.

Conversations about what still needs to be done on the matrix were talked about at the meeting, with Director Saunders. One big thing is to have signs where parking is available, that has been added to the matrix. It was a subject that was brought up when UNH visited.

Councilor Pepin attended a School Board meeting on Nov 14, 2017. Not much to report other than the High School chorus students gave a presentation to the School Board and wishes other people had the opportunity to see it.

Councilor Pepin attended a COAST bus meeting on Nov 15, 2017, approved an employee handbook. They also went over CIPI items for the next 5 years. COAST helps coordinate transportation for certain parts of the state for non-profit organizations for doctor's appointments etc. Somersworth, Dover and Rochester are not part of this but are looking into being added. For the month of September on Route 1 which is the downtown route 5,179 people used the bus. Year to date from October to now 62,886 people used the bus on Route 1. Route 2 which runs from Rochester to Dover for the month of September 16,396 used the bus. Year to date October to now 196,204 used the bus for Route 2.

Property. Eric Chinburg plans to attend the meeting. His attached email to Director Shanna Saunders sets some of the frame work as to why he wants to close on the property this month (HTC tax credits). I have also included copies of the Resolution passed by Council and an excerpt from the signed Purchase & Sales that indicates 30 apartments being proposed and some civic space. Mr. Chinburg has pointed out that although he may still be able to financially keep his original plan for apartments, there may be a need to do a more “mixed use development”, or an all business type of re-use for this facility to make it financially feasible.

City Manager’s Items (under section 10 of Agenda)

A. Informational Items.

- 1. CIP Fiscal Year 2019-2024.** In accordance with the City Charter, I hereby submit a proposed Capital Improvement Program for City Council consideration. I look forward to Council direction for future review and discussion opportunities.
- 2. Fiscal Year 2019-2020 Budget Preparation.** Next week I will be directing City Department Heads to begin their preliminary Budget requests for FY 2019-2020. I certainly welcome any specific Council direction as I prepare the City Manager’s Proposed Budget for submittal to the Mayor & Council by the Charter deadline of March 15.
- 3. Former Breton’s Cleaners (1 Winter Street).** We have submitted our Grant application to the US EPA for an additional \$200,000 in Brownfield’s Grant Funds to complete the clean-up of this site. Presently, the building has been demolished and the site buttoned-up. We will also be requesting an extension of the Grant deadline to allow Credere to examine soil test results and complete their final report as required by NH DES.

4. Grants.

- a)** Unless directed otherwise by City Council I will be authorizing a Grant application by the Fire Department for a Homeland Security Grant to purchase equipment in the amount of approximately \$6,000 for Best Practice equipment in responding to active threat situations. This is a companion Grant similar to the one awarded to the Police Department. Attached is a memorandum from Chief Hoyle that further explains this Grant program.
- b)** Attached are copies of memorandums from our various Department Heads that summarize our efforts over the last twelve (12) months or so to pursue Grant funds for our Community. I am pleased to inform you that we have secured over \$1M and are awaiting word on an

additional \$1M in Grant Funds. My thanks are extended to all of our Department Heads and their Staff for these tremendous efforts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the City Manager is authorized to contract with Wright Pierce Engineers at a cost not to exceed \$384,270 (Three Hundred Eighty Four Thousand Two Hundred Seventy Dollars) to provide engineering and design services for various complete streets projects and take any and all other such actions relative to these projects determined to be in the best interest of the City.

A: City Council certification of return of votes for November 7, 2017 Municipal Election
- Votes are certified.

After no discussion from the Council, the return of the votes is certified with a 9-0 vote.

C. Discussion vote presentation by Wright Pierce Engineers.

Councilor Witham updates the Council that two engineers were here tonight; they have completed their certification of the Somersworth Wastewater Treatment Facility. They looked at needs of the Wastewater Treatment Facility in terms of addressing flow, loading issues and as well as long term sustainability. They had some immediate improvements which we should be addressing immediately for 2017-2018, that was around \$4.2 million dollars. As heard in the workshop presentation prior to the City Council meeting there are a number of high priority items that should be addressed in 2018-2019 with another \$6.3 million, which brings it up over the \$10 million dollar mark. Councilor Witham thinks the Council should give Manager Belmore some direction.

Manager Belmore clarified that the Council has already approved the Resolution to hire Wright Pierce Engineers to complete the work. A new Resolution or a modified Resolution will be brought back to Council to further develop the plan.

Councilor Messier supports doing phase 1 and phase 2 that comes to a total \$10.5 million.

Councilor Dumont would like to look at the actual financing and bonding on the impact of our current rate for tax payers.

Councilor Messier for clarification they are not going for a bond, going to the State revolving loan fund. It doesn't affect the tax rate; it only affects the user rate.

Councilor McCallion looking at the latest and greatest, could they redesign and not just replace the existing. Operating costs down the road is his concern.

Councilor Witham this will likely be a bonded project, the cost would be bared by the rate payers not necessarily on the tax rate. Remind Council that we went through an exercise in the Finance and Public Works & Environment Committee where we looked at current wastewater rates and made modifications.

With no objection from Council the City Manager has consensus to move forward with drafting the first proposals.
