MAYOR'S REPORT

Mayors Report for City Council Meeting August 10, 2020

• This evening before the Council for first reading is **Resolution No. 10-21** "Requesting All Residents and Visitors, In the Strongest of Terms, To Wear Appropriate Face Coverings While In Public. All Business Owners and Places of Public Accommodation, to the Extent Not Already Covered Within Guidance Issued By The Governor, Are Requested to Develop Policies and Procedures, Including Appropriate Signage or Notices, Urging or Requiring Visitors to Wear Face Coverings"

Resolution 10-21 was developed after a meeting between the Tri-City Mayors and the urgency to continue to keep our three communities safe as we jointly continue to battle the COVID 19 outbreak. During that meeting each of the three Mayors agreed that the best approach would be to support and advocate for voluntary compliancy first, and continue to educated that public on why mask wearing will aid our communities towards flatting the curve and help us to expedite the return to normalcy. While the Resolution does not have any enforcement powers, it does officially put our municipal government on the record of supporting the use of masks within public. If the virus continues to spread and the problem within the Tri-City area worsens with the number of inflections, then the Tri-City Mayors will look towards the possibility of moving towards stronger requirements.

In the interim, we believe the best policy for our three communities is to continue to educate, advocate and increase the participation of voluntary compliance of mask wearing. The Rochester City Council has already passed the Resolution before you this evening, with the Dover City Council expected to take action this week. This evening I respectful request from Council a suspension of Council rules for a second reading on Resolution 10-21 and request your full support and passage. Together as a united community we will continue to inch closer and closer each day towards the return to normalcy.

• A return to normalcy continues to be a desire all of us are striving for. However, we must be mindful of what the reality of the current situation is and successfully as a united team navigate the waters before us. While this body would love to return to face to face meetings, the safety of each of its members and our ability to ensure we can continue to govern must take precedents over our own individual wants. Since March this body has successful continued to meet the needs of our city, its citizens and lead by example. We have honored and followed all fabrics of our democratic system, ensure open discussion and process take place, with input from the public and that each member's voice and vote continues to be registered. As promised, this week the City Manager, Deputy Mayor and I will be reviewing the current state of whether the Council will continue remotely into the fall or return to face to face meetings with restrictions within place. We will review all current data and guidelines and make the best decision which ensures the fidelity of our local democratic system, while also taking into account the safety of each member. We will also review the possibility of Council stand committees, and boards and commissions returning to a face to face schedule. Communication on our decision will be issued by the end of the week or early next week.

As always thank you for your tireless efforts in keeping Somersworth "On the Move" and ensuring our team approach to governing will continue.

REPORT OF STANDING COMMITTEES

<u>Finance</u> – Councilor Witham said the Finance Committee met on July 30^{th} at 10:30 with one member of the public present via zoom for the Nadeau Street topic. He stated we have already moved forward with thought of a betterment district for the three properties on the street which equates to approximately \$100,000 in improvements for the work. The way in which the residents approached us was nothing short of professional, but they would like to revisit the cost share. Councilor Witham wanted to remind Council the City had stumbled on the fact that Nadeau was not a City approved street. He stated the amount for the improvements agreed upon by the PW&E was \$26,000 which breaks down to \$11,000 in estimated interest savings by not charging interest as part of the assessment and \$15,000 which represents the City's estimate to overlay and shim the road.

Up next on the Finance Committee's agenda were the City CMAQ grant, which is a federal grant allowing us to improve traffic signals along the High Street corridor. There is a project amendment to add reflective panels around the traffic signal heads, for which there is grant money available and a small City match, which the Committee approved.

Councilor Witham also informed Council of TAP grant project amendment with CMA Engineers deals with some right-of-way acquisition.

The Committee also recommends moving forward with a five-year lease-purchase for an undercover police vehicle and a Public Works vehicle to include a plow. Councilor Witham also spoke about the COPs grant award to hire a new officer who will participate with the adverse childhood response team program. The officer will also have community policing responsibilities. The Finance Committee voted unanimously to support this COPs grant resolution.

Councilor Witham also spoke about the fire station building contract with Port One Architects who are providing the City with the initial design and have agreed to move forward for construction specifications and oversight work. The Finance Committee also supported the resolution for this contract (Resolution 5-21) unanimously.

The Finance Committee also discussed the fiscal year budget. When budget was passed the Mayor asked for us to revisit as we get closer to setting tax rates. The Finance committee recommend no action be taken on the approved fiscal year budget at this time.

<u>Government Operations</u> – Councilor Gerding stated the Government Operations Committee decided the proposed Ordinance 23-20 needed more clarity. Some were unsure and we wanted to table the item and get more information before getting to public hearing. Councilor Gerding also spoke to updates from City Manager in regard to employee staffing. Also discussed potentially pursuing an oversight committee in regards to hiring and police department oversight. Ultimately decided to put on pause and maybe come back next meeting with more information.

<u>Economic Development</u> – Councilor Dumont informed Council that the Economic Development Committee had a meeting this evening. Robin Comstock, Economic Development Manager, gave an update we haven't had in a while. Lot of moving pieces with corona, so progress has been somewhat limited. City Manager shared some good news that how we deal with the BP gas station moving forward is going to be different and no longer grandfathered as a gas station.

<u>Public Safety</u> – Councilor Pepin stated the Public Safety Committee met August 5^{th} via zoom. Police Department is reviewing applicants for a Parking Enforcement Officer. The Police Department calls saw an increase of 139 calls over last year. The Committee also voted in support the COPs grant. Councilor Pepin said the Committee discussed police officer body cams in regards to costs, maintenance, storage. Chief Kretschmar will be doing more research into that and providing a recommendation to the Manager. He said the Committee also discussed Resolution 6-21 to purchase police vehicles and voted to support it. He stated the Fire Chief reported that the specifications on the truck almost outfitted. He informed Council that the Fire Department discussed old turn out gear being donated to a technical program in the area for training. The Committee also discussed the proposed fireworks Ordinance. The Committee's recommendations were to keep the fee at \$5, and felt raising the fee would discourage those from getting a permit making it more difficult to track. He said the Committee also reviewed the times and felt 12:30 was fine to keep in the present Ordinance.

<u>Public Works & Environment</u> – Councilor Witham said the Committee met on July 30th. The Committee discussed some settling on Indigo Hill Road. Severino scheduled for repair work on 50-100 ft section. They also discussed punch list work to include some spot work and striping to be done in a few cross-walks. The Committee had a discussion on the Ord. 5-21 amendment to allow beekeeping. The Committee discussed and generally supported a change, although members wanted to have more specific language on location on a lot and the number of hives, etc. to consider. Councilor Witham also stated the Committee reviewed communication from Coolidge Law Firm regarding sidewalk insufficiencies on Constitutional Way. Constitutional Way is under a complete street engineering design process.

<u>Parks and Recreation</u>: Councilor Paradis informed Council that the Committee discussed the dog park which is near completion. Discussed final resolution to approve rules and signage for dog park, allowing advertising at the dog parks and other parks. She stated the Committee supports the passing of the proposed Resolution. The Committee heard about the millennium park update and hopes this park with be opening at the same time as the dog park.

REPORT OF SPECIAL COMMITTEES, CITY OFFICERS AND CITY MANAGER

<u>COAST</u> - Councilor Pepin informed Council the Committee had their annual meeting on July 29^{th} at which they reelected officers. The Committee discussed trying to educate people about the bus routes. The Committee also discussed their budget; however, many uncertainties remain. On July 9th the Committee had a meeting with CMA Engineering to review facility needs.

Fire Station Building Committee – Councilor Pepin informed Council that the Committee met on July 29th at 2 p.m. He said the City Manager gave a detailed report of the architect and how they got their design done with fire dept. staff assistance. The Committee did have discussion about going out for another RFP for another engineer to see if costs would come down, but did not want to start all over again. The Committee did support a Port One contract as in Resolution 5-21.

Joint Building Committee – Councilor Pepin stated the Committee had meetings on July 30th and August 6th. He said the walls in the music room are finished and carpets are in the process of being installed in classrooms. Councilor Pepin relayed discussions the Committee had of trying to get laundry room for nurse, custodian, and teachers. He also discussed having driveway where loading dock is going to be repaved.

<u>Election Review Planning Commission</u> – Councilor Paradis informed Council that the Committee met last Wednesday, July 29th. She said discussions lead to draft plan of recommendations, the objective being, to develop a plan under state laws and restrictions to ensure safety of voters and workers. She spoke to these recommendations which include masks and hand sanitizers for workers and voters, locations being closed for daily business on those days, and recommending the doors to be propped open when possible. She also stated the location changes for the polling places was noted and signs to be posted at the old locations in case people don't know about the changes. Councilor Paradis also said the committee stressed the \$75 stipend for poll worker staff to include city staff. The Commission also discussed encouragement of absentee voting and the absentee ballots can be counted after 1pm. The Committee also recommended stressing absentee voting for the General Election in November.

<u>Historic District Commission</u> – Councilor Gerding gave an update on the Commission who met in July. The Commission discussed a new home build on winter street that was approved with amendments to add features to better fit in with the neighbors. The Commission also discussed a resident who wanted to add deck and screened porch on Maple. The resident was willing to put on a false chimney since one had to be taken down. There was also a project on Linden Street to install retaining wall (rock) which they were happy to change. Lastly, the Commission discussed a home looking to replace roof with new product (aluminum shingle) to mimic old style roof.

Unfinished Business (Under Section 14 of Agenda)

Ordinances

- A. Ordinance No. 23-20: To Amend Chapter 4, Personnel Rules & Regulations, Section 11.3.1, Health/Dental Insurance, Regarding Spouses Employed by the City. The Government Operations met on August 4th and continued the matter for further evaluation. This Ordinance change remains in Committee.
- **B.** Ordinance No. 1-21: To Amend Chapter 30, Conduct in Public Parks, Section 13, Dog Waste in Parks, by Adding Section D, Dog Park Rules. Again, the Recreation Committee voted to support this Ordinance amendment at their June 3rd meeting.
- C. Ordinance No. 2-21: To Amend Chapter 30, Conduct in Public Parks, Section 8 – Regarding Advertising. Again, the Recreation Committee reviewed and voted to support this Ordinance amendment at their June 23rd meeting.
- **D. Ordinance No. 3-21: To Amend Chapter 21A, Display of Permissible Fireworks.** The Public Safety Committee met on August 5th and voted to recommend amendments to this proposed Ordinance change. Attached is the *red*-

lined proposed amendment(s) with the recommended changes to be presented by Committee members. The Committee is advocating keeping the application fee at \$5.00 as well as making no changes to the allowed fireworks discharging times. The Committee supports the penalty fine increases.

- **E. Ordinance No. 4-21: Transfer Ordinance for Fire Staffing Funding.** Again, this Ordinance is in support of Resolution No. 49-20 which was adopted at the June 15th Council meeting. Money appropriated to replace Fire Department mobile radios will be used to cover the projected increase in cost of overtime and associated payroll roll-up costs.
- **F. Ordinance No. 5-21:** To Amend Chapter 19 Zoning, Section 25.B, Agricultural Use. The Public Works & Environment Committee met on July 30th and asked the City Manager to provide some research on alternative language for their consideration. This Ordinance change remains in Committee.
- G. Ordinance No. 6-21: To Add to Chapter 19, Zoning, Section 32, Form Based Codes. Again, this proposed Amendment has been in the works for some 18-plus months. The City Attorney has reviewed this language and he has no proposed changes.

New Business (Under Section 15 of Agenda)

Resolutions

- A. Resolution No. 2-21: To Authorize the City Manager to Enter into a Grant Agreement with the United States Department of Justice Cops Hiring Program to add One Additional Police Officer. The City was notified in June that we were awarded a \$125,000 Grant over a three year period to assist in funding one additional officer. This would leave an estimated cost of \$165,038.00 to the City over the three year period of the Grant. Additionally, the City would be required to retain the officer for a period of one year upon expiration of the grant. It is anticipated that the grant position would be assigned to the Patrol Division of the Police Department. In addition to patrol duties, this officer would be assigned as a Community Policing Officer, overseeing programs such as National Night Out, Pizza with the Police, Coffee with a Cop and a new program known as ACERT. Please see Chief Kretschmar's memorandum for further explanation.
- **B.** Resolution No. 3- 21: To Authorize the City Manager to Prepare Bid Specifications for Road Resurfacing and Associated Repairs of Selected Streets. The Public Works & Environment Committee met on July 7th and voted to support this Road Resurfacing plan. I want to point out, if adopted, the road resurfacing would be conducted in 2021, the crack sealing would be completed prior to this winter of 2020. Attached is a Memorandum from City Engineer Gary Lemay providing more detail on these repairs.

- **C. Resolution No. 4 -21:** Authorizing the City Manager to Sign a Lease/Purchase Agreement for the Purchase of City Vehicles. The Finance Committee voted to support this Resolution on June 9th. Please see Finance Director Scott Smith's memorandum that outlines the Proposals received. At the conclusion of the lease financing, the City will own the vehicles.
- D. Resolution No. 5-21: To Authorize the City Manager to Contract with Port One Architects of Portsmouth, NH to Provide Final Design Services to Construct a New Fire Station at The Location of the Current Fire Station on Maple Street. The Finance Committee and the Fire Station Building Committee voted to recommend the City continue with the services of Port One Architects. Attached is the cost page from the draft Port One proposed contract.
- **E.** Resolution No. 6-21: To Authorize the City Manager to Order One SUV Style Police Cruiser and One Undercover Police Vehicle Which will be Funded by a Lease Purchase Agreement. Resolutions 6-21 and Resolution 7-21 are the actual purchases that will be made should the lease financing be approved. These purchases were approved by the City Council in the FY 2021 Budget. Attached is further information from Chief Kretschmar regarding these replacement vehicles as well as the associated CIP document pages.
- F. Resolution No. 7-21: To Authorize the City Manager to Order a Ford Pick-Up Truck for the Department of Public Works Which will be Funded by a Lease Purchase Agreement. Attached is the CIP page for this vehicle. The present vehicle is earmarked for trade-in.
- **G.** Resolution No. 8-21: To Authorize the City Council to Establish a Betterment Assessment for the Purpose of Reconstructing Nadeau Street and Accepting it as a City Street. The Public Works & Environment and Finance Committee met on July 30th to discuss the possibility of some cost sharing with the Residents who have agreed to fund the road upgrades so that the City Council will be in the position to accept the road as a City approved road. Attached is a Memorandum from City Engineer Gary Lemay outlining the cost estimates for needed repairs as well as other steps required such as survey and Planning Board approval.
- H. Resolution No. 9-21: To Authorize the City Manager to Amend the Contract with CMA Engineers of Portsmouth, NH for Engineering Service associated with the Transportation Alternatives Program Grant. The Finance Committee met on July 30th and voted to recommend this amendment to the full City Council. Attached is a spreadsheet that outlines the funding needed to move this project forward.
- I. Resolution No. 10-21: Resolution Requesting all Residents and Visitors, in the Strongest of Terms, to Wear Appropriate Face Coverings While in Public. All Business Owners and Places of Public Accommodation, To the Extent not Already Covered Within Guidance Issued by The Governor, are Requested to

Develop Policies and Procedures, Including Appropriate Signage Or Notices, Urging or Requiring Visitors to Wear Face Coverings.

Councilor Witham indicated his thought is to get this moving since getting the vehicle in order is frequently delayed.

Councilor Paradis inquired about the funding being approved already for the vehicle and that this is just an approval to order the specific vehicle. The City Manager clarified what was previously approved was a down payment as funding. Councilor Paradis asked if this was in capital improvement plan. The City Manager said it is included in the plan, but as we move forward Council leasing approval needs to be secured.

Councilor Pepin made a motion to approve Resolution 10-21. The motion was seconded by Councilor Gerding and passed 7-0 by roll call vote.

Councilor Paradis stated she supports this resolution and wishes to send a copy to the Governor in order to urge him to provide guidance. She also hopes to be added as a sponsor to the Resolution. The wish to be added as a sponsor was echoed by Councilors Witham and Pepin.

OTHER

A. Approval of the recommendations from the Election Review Planning Commission

The approval of the recommendation from the Election Review Planning Commission passed 7-0 by roll call vote.

CLOSING COMMENTS BY COUNCIL MEMBERS

Councilor Pepin stated he was glad to see the list of the roads to be paved next year as it includes several side streets. He also wanted to welcome the new City Clerk.

Councilor Vincent wanted to acknowledge the passing of his business partner, John Gregoire. He was a great individual, citizen of Somersworth, and fire fighter. Councilor Vincent indicated Mr. Gregoire served on committees from the city (veterans park committee) and was an outstanding individual who was always good for a joke. Councilor Vincent also stated he has been hearing concerns about how the flag policy is being run. The resident was not concerned about the politics, rather the control of the flag. The Mayor stated he spoke with resident also and options are being explored.

Councilor Dumont wanted to send his condolences to the Gregoire family. He also wanted to compliment both the Public Works Department for getting the road repair list ready and to thank the drive-up window employees. He indicated he wants to post busy times for the window. Councilor Dumont also extends appreciation to the school board, superintendent, and staff. His hat goes off to them. Councilor Dumont wanted to suggest a black-out period on Council and Committee meetings so people can take their time off etc. Councilor Dumont wanted also to discuss on-call fire departments. Reality is we were built on on-call fire departments. One of our neighbors operates a fully volunteer force in Kittery, Maine. We can't take these types of people and forget about them. We have had some great call fire departments. He thinks there needs to be a different perspective. Councilor Dumont also wanted to address a new moniker for people who don't agree with the past. The term is "cancel-culture". He would encourage Councilors to research and look at what this is doing to our country. It has to do with statues being removed etc. For him, putting ten years in the

military, protecting peoples' right to express themselves. Councilor Dumont also wanted to extend a large thanks to the pastor at Ignatius church. He indicated his parish met as a family in car-church. Audio came through speakers and there was a great turn out.

Councilor Austin wanted to reiterate the meeting with the School Board. He said he was impressed by the thoughtful approach taken by the Board. Superintendent presented a good, well thought out, plan. Congrats to the workers and staff who have not had time off in order to continue educational planning. Since March nearly 400,000 people have been diagnosed, 100,000 in the last two weeks. He stated he was glad we passed the mask ordinance and we should do everything we can to help people understand the implications, good and bad of wearing or not wearing a mask. If we want to open up schools, restaurants, etc., we need to wear masks.

Councilor Witham also wanted to extend condolences to the Gregoire family. He stated he received communication from a resident about getting back to some sort of semblance of normal. If we do remain in remote status, the concern is public access. He wants to consider allowing residents to enter meeting on zoom. Councilor Witham also wanted to give kudos to the fire chief for handling a storm event. He said it was one of the best commanded events he's ever heard and was executed flawlessly. Councilor Witham is also pleased to hear we have a Parking Enforcement Officer almost onboard. He has been seeing many flagrant violations of our parking ordinance every day. He also wanted to point out that the fence at the dog park on Stackpole Road is being done very poorly. He believes it is so bad it needs to come down and be redone. Councilor Witham also wanted to point out some maintenance necessary to the police station's lawn, shrubs and lighting.

Councilor Gerding wanted to compliment staff on new park and gazebo; they look great. He also wanted to wish all families and educators a happy end of summer. Councilor Gerding said he is happy to see the mask resolution move forward and is extra pleased to see it came through as a tri-city resolution, making it that much more impactful.

Councilor Paradis wanted to welcome the new city clerk. She said he has been great interacting with him and heard only good comments from others. Councilor Paradis also wanted to share an idea passed by her by a resident to install street murals to support positive messages around the community. She asked Economic Development Manager, Robin Comstock if she felt this would positively impact on an economic basis to which she replied in the affirmative. Councilor Paradis hopes we pick this up for discussion in order to help our small businesses. She also wanted to relay an issue she has been hearing from residents a lot lately, which is Police Department funding. As she has been paying attention to data etc., she has also been keeping tabs on information on things useful to Somersworth. Recently Kretschmar discussed how challenges and success for a police department are driven by the culture itself. She knows our police department is dedicated. She has learned that what helps them greatly is proactively building relationships in the community. There is a grant coming up before us, COPS hiring grant, a federally awarded grant towards hiring a police officer. The program that the new officer would be assigned to would be coffee with a cop and other new initiatives. Councilor Paradis is definitely in full support of community policing with or without the approval of the resolution. COPS hiring grant adds \$260,000 over the next four years towards expanding in what is expected to be a permanent way. She has heard we are

understaffed compared to calls, though many calls are from the same people an officer sees every day. The question on her mind is, how to find a better way to address the root problem of these common calls. Many have mental, drug issues and each issue have a professional outlet to offer assistance. Councilor Paradis spoke to having officers diverting individuals to other assistance programs if they deem the individual to be appropriate for the program. She would like to see the City expand the capacity on both sides, not just having our Police Department address every community problem in order to better serve the basic needs of our community. She expressed that a number of residents have expressed the desire to explore other ways to alleviate issues currently being addressed by the Police Department, and rather redirect to other helpful agencies.







19.32.A Purpose and Intent


- **19.32.A.1** The City of Somersworth Form Based Code Overlay District follows the premises of context sensitive zoning. This Code is intended to foster a vibrant Main Street both for itself and for its adjacent neighborhoods through a lively mix of uses—with shopfronts, sidewalk cafes, and other commercial uses at street level, enhanced by canopy shade trees, upper story residences and offices.
- **19.32.A.2** To allow further refinement consistent with individual areas, the Form-Based Code Overlay District has been divided into sub-districts, with special requirements for each sub-district to allow for context sensitive development along corridors and neighborhoods alike.
- **19.32.A.3** All of the areas within the Form-Based Code Overlay District share a common goal of increased emphasis on the form and placement of structures, and a decreased emphasis on the function(s) contained within them. As such this Section sets careful and clear controls on building form— with broader parameters on building use—so as to shape clear, attractive public spaces (good streets, neighborhoods and parks) with a healthy mix of uses. With proper urban form, a greater integration of building uses is natural and comfortable.







- **19.32.B.1** Artist Studios– Work space for one or more artists or artisans, including the accessory sale of art produced on the premises.
- **19.32.B.2** Balustrade A railing supported by balusters, commonly an ornamental parapet on a balcony, bridge, or terrace.
- **19.32.B.3** Banding A horizontal band at least six inches thick applied to the Façade of a building, that offers a change in color, texture, pattern, material, or relief from the main siding material.
- **19.32.B.4** Bay The space between architectural elements, or a recess or compartment, in the façade.
- **19.32.B.5** Bioswale A channeled depression or trench that receives rainwater runoff and has vegetation (such as grasses, perennial flowers herbs, shrubs, and trees) and organic matter (such as compost and mulch) to accommodate water infiltration and filter out pollutants.
- **19.32.B.6** Build to Line A line parallel to the street right-of-way line at any story level of a building, and representing the minimum distance which any part of the building is set back from said right-of-way line.
- **19.32.B.7** Corbel Bracket or weight-carrying member, built deeply into the wall so that the pressure on its embedded portion counteracts any tendency to overturn or fall outward.




- **19.32.B.8** Cornice Decorative trim located at the meeting point between walls and a roof or ceiling.
- **19.32.B.9** Decorative Lighting Exterior lighting that enhances the appearance of the structure using downcast and shielded fixtures.
- **19.32.B.10**Depth (Building) the variation of a building facade that provides visual interest and compatibility of scale.














- **19.32.B.11** Eating & Drinking Establishments Any establishment, however designated, at which food is sold for consumption on the premises to patrons seated within an enclosed building, or elsewhere on the premises. Drive-thru access is not permitted.
- **19.32.B.12** Entrance canopies A structure, often canvas, mounted to a building to shelter an area or form a sheltered access to the entrance of a building.
- **19.32.B.13** Façade The front of a building facing a street or other public space.
- **19.32.B.14** Frieze a sculptured or richly ornamented band on a building.
- **19.32.B.15** Frontage Build-Out The percentage of the linear distance measured along the front lot line that is occupied by the primary structure.
- **19.32.B.16** Green Wall Vegetation growing on or against a vertical surface.
- **19.32.B.17** Human scale The perceived size of a building, or related appurtences (lighting, signage, etc) relative to a human being.
- **19.32.B.18** Lintel A horizontal support of timber, stone, concrete, or steel across the top of a door or window.
- **19.32.B.19** Lodging Structures providing overnight accommodations for individuals on a temporary basis.




- 19.32.B.20 Mass Refers to the size or physical bulk of a building.
- **19.32.B.21** Pediment A triangular gable forming the end of the roof slope over a portico (the area, with a roof supported by columns, leading to the entrance of a building); or a similar form used decoratively over a doorway or window.
- **19.32.B.22** Professional Services & Offices Businesses offering services for others, predominately on premises, and often by someone engaged in that work as a career.












- **19.32.B.24** Rain garden An engineered system consisting of a slightly depressed landscaped area constructed with a specialized soil mixture, an aggregate base, an underdrain, and site-appropriate plant materials that tolerate both moist and dry conditions.
- **19.32.B.25** Roofline The profile of a roof including its slope and cladding which forms the frontage immediately below the roof and the eaves of a structure.
- **19.32.B.26** Shutters Lightweight, sometimes louvered, decorative frames in the form of doors located on the sides of a window.
- **19.32.B.27** Streetscape The visual elements of a street, including the road, adjoining buildings, sidewalks, street furniture, trees and open spaces that combine to form the street's character.
- **19.32.B.28** Transom (Window) Horizontal windows installed above doors and windows that generally match the width of the opening.
- **19.32.B.29** Treebox filters A 'boxed' bioretention cell that is placed at the curb (typically where storm drain inlets are positioned). It receive storm water runoff along the curb and the storm water is then filtered through layers of soil, feeding the tree, before it enters a drain or basin.

19.32.B.30 Trim - The finish materials on the exterior a building, such as moldings applied around openings (window trim, door trim), siding, windows, exterior doors, attic vents, crawl space vents, shutters, etc.

19.32.C Form Based Codes Overlay District Boundaries

- **19.32.C.1** The Form Based Code Overlay District includes Tax Map Lot 11-181A, formerly known as Breton's Cleaners, crosses Winter Street to include Tax Map Lot 11-96 known as the Queensbury Mill then runs along the rear property line of all lots that front on the south side of Market Street, crosses Prospect Street, including Lots 11-78 and 11-77, crosses Beacon Street and then runs along the rear boundary line of all property Lots that front on the western side of High Street up to Hamilton Street, and the SW corner of Tax Map Lot 10-129.
- 19.32.C.2 The Overlay District Boundary then crosses High Street to the southernmost corner of Tax Map Lot 10-163 then runs along the rear property line of all property Lots that front the easterly side of High Street to Constitutional Way and the NE corner of Lot 10-155, except the whole of Lot 10-152. Property Lot 10-152 has two frontages on High Street, one of 90 feet and one of 105 feet. The Overlay District exists on Lot 10-152 approximately 100 feet deep from High Street on those two frontages, only.
- **19.32.C.3** The Form Based Code Overlay District then includes Property Lot 10-153A and Lot 10-153 on Constitutional Way, runs kitty-corner across Washington Street to the NE corner of Lot 10-170, then runs along the rear boundary line of all property Lots that front on the eastern side of Green Street down to Fayette Street, then down Fayette Street to include Lots 10-177 and 10-179. The Overlay District then crosses Main Street and runs northerly up the property line of Main Street and the NH NorthCoast Corp RR line up to the SW corner of Property Lot 11-205 across from the Somersworth Plaza driveway. The District then runs 25 feet easterly up the side boundary line of property Lot 11-205 and runs along the rear property line of all property Lots that front on the easterly side of Main Street and Market Street, crossing Canal Street and running along the rear property lone of all property Lots that front on the easterly side of Market Street ending at the Somersworth/Berwick Bridge.
- **19.32.C.4** This boundary is the exterior boundary and all property Lots within this exterior loop are also within the Form Based Code Overlay District.

19.32.C.5 The Form Based Code Overlay District also includes Property Lots 11-190, 11-190A, 1190B, 11-191, 10-196, 10-199, 09-282 and 09-282C

19.32.D Sub-Districts

- **19.32.D.1** The five Area Sub-District Sheets (Areas 1 5) for the Form-Based Code Overlay District shall locate the boundaries for the following sub-districts:
 - a) Downtownb) High Streetc) Main Streetd) Residentiale) Millyard

19.32.E Permitted Uses

- **19.32.E.1** The standards for use and dimensions to be utilized within the Form Based Codes Overlay District are shown on the front of the five (5) Area Sub-District Sheets (Areas 1-5) at the end of this section.
- **19.32.E.2** Determination of Use Category The Director of Development Services or their designee shall determine in which use category, in the Permitted Uses Table, on each district sheet, a proposed use is located. When a use is not specifically listed, the Director of Development Services or their designee is authorized to determine if the use is similar enough to be placed in a category or if the use is prohibited by this Chapter.
- **19.32.E.3** Uses Where uses are not specifically called out in the Permitted Use Table an applicant may submit a Conditional Use Permit for their proposed use.
- **19.32.E.4** Criteria for granting a Conditional Use Permit:
 - a. Both public and private buildings and landscaping contribute to the aesthetic value of the right of way and provide civic spaces.
 - b. Development adequately accommodates automobiles, while respecting the pedestrian and the spatial form of public areas.
 - c. The design of streets and buildings reinforces a safe environment, but not at the expense of accessibility.
 - d. The architecture and landscape designs are inspired by local climate, topography, history, and building practice.
 - e. Civic spaces and public gathering places are provided as locations that reinforce community identity and activity.

19.32.F Dimensional Regulations

19.32.F.1 The dimensional regulations to be utilized within the Form Based Codes Overlay District are shown on the front of the five (5) Area Sub-District Sheets (Areas 1-5) at the end of this section.

19.32.F.2 Anything cited as "per ordinance" refers to Table 5.A.1 in the Zoning Ordinance entitled "Dimensional and Density Regulations".

19.32.G Architectural Standards

- **19.32.G.1** The architectural standards to be utilized within the Form Based Codes Overlay District are shown on the back of the five (5) Area Sub-District Sheets (Areas 1 5) at the end of this section.
- **19.32.G.2** Waivers may be used to adjust the architectural standards, but designs must still meet the intent of these standards. In the case of Commercial or Multifamily use waivers shall be granted by the Planning Board if appropriate. In the case of Single family or duplex development waivers shall be granted by the Director of Development Services or their designee, if appropriate.
- **19.32.G.3** Any property within the Form-Based Code Overlay District that is ALSO within the Historic Overlay District shall meet the requirements of Section 14 of the Zoning Ordinance. A Historic District Application might be required.

19.32.H Streetscape Standards

19.32.H.1 The streetscape standards to be utilized within the Form Based Codes Overlay District are shown on the back of the five (5) Area Sub-District Sheets (Areas 1 - 5) at the end of the section.

19.32.I Administration

- **19.32.I.1** The Form-Based Code Overlay District exists like every other district and development within, is intended to be reviewed and approved as any other district. For development standards not covered herein, the other applicable sections of the City of Somersworth Ordinance and Regulations shall be used as the requirement. Commercial and Multifamily projects submitted shall follow the process outlined within the Site Review Regulations.
- **19.32.I.2** Any appeals of this section shall be treated as any other zoning appeal and shall be directed to the Zoning Board of Appeals.

RESOLUTION REQUESTING ALL RESIDENTS AND VISITORS, IN THE STRONGEST OF TERMS, TO WEAR APPROPRIATE FACE COVERINGS WHILE IN PUBLIC. ALL BUSINESS OWNERS AND PLACES OF PUBLIC ACCOMMODATION, TO THE EXTENT NOT ALREADY COVERED WITHIN GUIDANCE ISSUED BY THE GOVERNOR, ARE REQUESTED TO DEVELOP POLICIES AND PROCEDURES, INCLUDING APPROPRIATE SIGNAGE OR NOTICES, URGING OR REQUIRING VISITORS TO WEAR FACE COVERINGS

August 10, 2020

WHEREAS:	The condition known as coronavirus disease 2019 ("COVID-19"), which is caused by the novel coronavirus (SARS-CoV-2), is presently affecting individuals throughout the United States and the State of New Hampshire; and
WHEREAS:	COVID-19 is potentially fatal, predominantly but not exclusively for those at high risk; and
WHEREAS:	Continuing studies into COVID-19's non-fatal effects increasingly reveal damage, including long-term irreversible damage, to various human organs, including the lungs, heart, and possibly the brain and other organs or organ systems; and
WHEREAS:	On March 13, 2020, Governor Christopher Sununu issued Executive Order 2020-04, declaring a state of emergency in New Hampshire with respect to COVID-19 (novel coronavirus); and
WHEREAS:	The Governor, the federal Centers for Disease Control and Prevention ("CDC"), President Trump, and the World Health Organization ("WHO") have issued or recommended further restrictions aimed at minimizing exposure to the novel

coronavirus, including social distancing, hygienic practices (*e.g.*, handwashing), and, now, face coverings; and

- WHEREAS: Having had the opportunity to study the virus for several months, the CDC has confirmed that the virus spreads mainly from person to person through respiratory droplets produced when an infected person coughs, sneezes, talks, or raises their voice (*e.g.*, shouting, chanting, singing); and
- WHEREAS: The CDC has also confirmed that a significant number of those infected with the virus are either asymptomatic or pre-symptomatic, yet can still readily transmit the virus to others unknowingly; and
- WHEREAS: Multiple independent studies confirm, and agree, that widespread wearing of face coverings helps drastically reduce transmission of the virus to others by (i) reducing the amount of viral load exhaled or expelled into the air surrounding an infected person, and (ii) reducing the distance which that viral load travels or can travel; and
- WHEREAS: Face coverings, and particularly medical grade ones, may also help protect the wearer to some degree; and
- WHEREAS: Guidance from medical experts across the country strongly recommends the wearing of face coverings when in public, and particularly where a person is not able to maintain adequate distance from another person; and
- WHEREAS: It is incumbent upon every resident and visitor in the City of Somersworth to take all measures reasonably possible to protect the public health; and
- WHEREAS: The purpose of this resolution is to ensure public awareness of the importance of face coverings, as well as ensure business owners are aware that they have the right, as a property owner or possessor, to control the manner of use of their property; and
- WHEREAS: This Resolution is being sponsored by the Tri-City Mayors of Somersworth, Rochester, and Dover

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND SOMERSWORTH CITY COUNCIL THAT:

All residents and visitors within the City of Somersworth who are medically able, are hereby requested, in the strongest of terms, to wear appropriate face coverings while in public. Face coverings should cover the nose and mouth of the person wearing it.

AND, BE IT FURTHER RESOLVED THAT:

All business owners and places of public accommodation, to the extent not already covered within guidance issued by the Governor, are requested to develop policies and procedures, including appropriate signage or notices, urging or requiring visitors to wear face coverings.
