

Discussion

03/15/2021

Councilor Witham made a motion to suspend Council rules to allow Ordinance No. 13-21 to be read by title only. The motion was seconded by Councilor Vincent and passed 9-0 by roll call vote. City Clerk Slaven performed a first reading of Ordinance No. 13-21 by title only.

Councilor Witham made a motion to suspend Council rules to allow for a second reading of Ordinance No. 13-21. The motion was seconded by Councilor Vincent and passed 9-0 by roll call vote. City Clerk Slaven performed a second reading of Ordinance No. 13-21 by title only.

Councilor Witham made a motion to lay Ordinance No. 13-21 upon the table. The motion was seconded by Councilor Vincent and passed 9-0 by roll call vote.

04/05/2021

Councilor Witham made a motion to remove Ordinance No. 13-21 from the table. The motion was seconded by Councilor Paradis and passed 8-0 by roll call vote.

Councilor Witham made a motion to amend Ordinance No. 13-21 FY 2021-2022 Budget by reducing the health insurance premium line item by \$54,577. The motion was seconded by Councilor Gerding and passed 8-0 by roll call vote.

Councilor Witham explained the reason for the reduction is due to the way the health insurance budget is submitted. It is done so using the guaranteed maximum rate increase from the health insurance provider and the City does not receive the actual rate until the budget is submitted. By level funding it allows us to avoid a large swing on this item in the budget for this year and next.

Councilor Witham made a motion to amend Ordinance No. 13-21 FY 2021-2022 Budget by allocating \$2,500.00 to Stafford Nutrition Meals on Wheels (Page C-8, Elected Leadership, Community Support). The motion was seconded by Councilor Austin and passed 8-0 by roll call vote.

Councilor Vincent noted that this program supplies 18,000 meals a year to 274 Somersworth residents. He also mentioned that a great part of the program is it gives a social interaction to some who have no other contact with anyone throughout the day.

Councilor Witham made a motion to place Ordinance No. 13-21 on the table. The motion was seconded by Councilor Austin and passed 8-0 by roll call vote.
