Correspondence: Response from Somersworth Conservation Commission re: tree replanting</p>	<p>The Conservation Commission sent the Sustainability Committee a UNH Cooperative Extension list of native trees. The Conservation Commission asked for more specifics about the proposal. Would the trees need to be planted in the same location? Whose budget would pay for the trees? What about trees removed as hazards?</p> <p>Doug Watson and Councilor Soldati noted that other communities, such as Portsmouth and Atlanta, have such policies, so that Somersworth might be able to model its policy after them.</p> <p>There was discussion among all members about choosing native trees that are drought resistant.</p>	<p>Councilor Soldati took the action item to research the types of trees to recommend. Doug Watson took the action item to research policies in other cities.</p>

Updates on energy reduction plan</p>	<p>Doug Watson presented a synopsis of the latest Farm to School meeting.</p> <p>The Sustainability Committee was asked to suggest locations for the mobile market to open in Somersworth. The discussion surrounded accessibility to low income and elderly communities and well-trafficked locations.</p> <p>The community garden is at capacity. There is talk of expanding it, and if so, where to locate it.</p> <p>There was a suggestion to designate "edible" Adopt-a-Spot locations.</p> <p>No updates on the energy reduction plan.</p>	<p>Doug Watson will pass on the Committee's recommendations for either Bartlett Ave., near the early learning center, or Government Plaza. The Committee also suggested (but did not recommend) rotating between the two.</p> <p>Sarah McGraw will take pictures of the community garden and submit them to Brenda Breda for the August newsletter.</p> <p>Mike Bobinsky took the action item to look into a map of open space and parks.</p>
