Maskwa stated he was not present last month with the decision to deny was issued but that he has read the record and all materials and feel that he is comfortable with deliberating and deciding on this rehearing request tonight.

Maskwa stated that he agrees with Keiser and Routhier and that he feels that the letter from Joe Devine points out specific things and that the Board should look at those and see if they comply with the variance. Stated that he is in favor of granting the rehearing request.

Routhier stated that he feels that there isn't much to discuss tonight and that he wants to ensure that this is handled correctly.

Motion: Keiser moved that the rehearing request of the Zoning Board's decision to deny an appeal from administrative decision regarding the use at property located at 29 Lil Nor Avenue be **APPROVED**.
